FEEDING DIRECTIONS

Feed continuously to growing broiler or turkeys as the sole ration. The optimum level depends upon the severity of coccidiosis exposure.

Warning Statement: Do not feed to laying hens. Do not feed to chickens over 16 weeks of age. CAUTION:-----Do not allow horses, other equines, mature turkeys or guinea fowl access to feed containing Monensin. Ingestion of Monensin by horses, mature turkeys, and guinea fowl has been fatal. Some strains of turkey coccidian may be monensin tolerant or resistant. Monensin may interfere with development of immunity to turkey coccidiosis.
